**Background:**

1. **Legislators estimate that every contact from a voter represents 1,000 other voters!**  
**YOU HAVE A LOT OF POWER – USE IT!**  
**Each phone call should take 15-30 seconds.**

There are 24 Committee members (see below). You may get a recording or a live assistant. Do not get into a discussion.

2. **Support HB1229 language amendments.**

ONLY ONE property tax bill, HB1229, eliminates property taxes (and more) and REPLACES the money with a simple expansion of sales tax on services.

**HB1229 simplified:**

**Eliminates: (PART)**

- Eliminates Property Taxes
- Eliminates Assessors
- Eliminates Referenda
- Eliminates TIFS

**All of these have been abused and need to be ELIMINATED – FOR EVERYONE, not just special interest groups.**

**Funding:**

**EXPAND the 7% sales tax to services**, with certain exceptions for medical expenses  
**This will REPLACE all the eliminated property tax revenue, PLUS ISA says it will generate additional \$ MILLIONS in revenue; any EXCESS should go to road funding!**  
**No Need to do more with less!**

**State Benefits:** Easy and inexpensive to administer

Attract business and voters to Indiana, as the FIRST state to eliminate property tax.

Property tax elimination is being discussed at the national level by Trump and Musk. Support their efforts.
